Project Engineer – I : Project Engineer-I will be engaged initially for a period of THREE years which may be extended for one more year based on Project requirement and individual's performance.

RETENTION BONUS for Project Engineer : Project Engineer-I who complete overall tenure of 4 years will be entitled for Retention Bonus of Rs.25,000/- for every completed year. However, the retention bonus will be payable at the end of 4 years i.e.Rs.1,00,000/-

3.0 UPPER AGE LIMIT AS ON 01.09.2024:

Trainee Engineer/Officer – I: The age limit should not be more than 28 years for General/EWS candidates.

- i.) The upper age limit will be relaxable for OBC candidates by 3 years and SC/ST candidates by 05 years. For candidates belonging to PwBD category having 40% disability or more will get 10 years' relaxation in addition to the relaxation applicable to the categories mentioned above.

Project Engineer – I: The age limit should not be more than 32 years for General & EWS candidates.

- ii.) The upper age limit will be relaxable for OBC candidates by 03 years and SC/ST candidates by 05 years. For candidates belonging to PwBD category having 40% disability or more will get 10 years' relaxation in addition to the relaxation applicable to the categories mentioned above.

iii.) SSLC/SSC/ISC mark card and any other valid document will be considered as proof of date of birth.

- ii.) **Selection process of Trainee Engineer-I** will be through Written test of 100 marks with negative marking of 1/4 mark for each wrong response.
- iii.) In case of tie in marks, the overall percentage of marks obtained in the qualifying degree shall be considered to determine the merit and resolve the tie.
- iv.) Minimum qualifying marks required for suitability for different categories of candidates are as under:
 GEN/EWS/OBC-NCL: 35% and for SC/ST/PwBD -30%
 However, candidate will be selected in the order of merit i.e. category wise, Discipline wise.
- v.) Selection process for Trainee Engineer will be done at following locations- Delhi-NCR, Jammu, Kolkatta and Bangalore. Candidates have to give their preference. No request for change of examination Centre/Venue/date/session will be entertained after final submission of online application form. However, BEL Management reserves the right to cancel or add any centre depending upon the response of candidates in that area/Centre, administrative feasibility, etc.
- vi.) The names of candidates shortlisted for written test and final selection will be notified on our Company’s website.

SELECTION PROCEDURE of PROJECT ENGINEER-I:

- i.) Selection of Project Engineer will be through Written test followed by Interview for shortlisted candidates.
- ii.) Minimum qualifying marks required for suitability for different categories of candidates are as under:

- iii.) The assessment weightage will be 85% and 15% for written test and interview respectively
- iv.) Selection process of Project Engineer will be conducted at Vadsar / Ahmedabad, Kolkatta, Bangalore and Delhi/NCR. Candidates have to give their preference. No request for change of examination Centre/Venue/date/session will be entertained after final submission of online application form. However, BEL Management reserves the right to cancel or add any centre depending upon the response of candidates in that area/Centre, administrative feasibility, etc.

- v.) The names of candidates shortlisted for written test/Interview and final selection will be notified on our Company's website.

Please Note:

- iv.) Proof of norms for CGPA/DGPA/OGPA or letter grade/document for percentage/class issued by University/Institution/College.
- v.) Caste/Tribe/Community/Disability/Economic status Certificate in case of candidates belonging to SC/ST/OBC/PwBD/EWS respectively. Candidates claiming reservation under any of the above categories are required to submit the certificate in the prescribed format.
