AGE: Should have completed minimum 14 (fourteen) years of age as on 31-12-2024.

RESERVATION: The reservation of training placements for the Scheduled Castes, Scheduled Tribes and Other Backward Classes shall be as per Rule of reservation on the basis of total number of placements in terms of Apprentices Act,1961.

MODE AND CRITERIA OF ENGAGEMENT OF APPRENTICES:

- Engagement of Trade Apprentices will be made purely on the merit basis of aggregate marks obtained by the candidates in ITI.
- Preference will be given to the children of VPA Employees in the ratio of 4:1:1 i.e 4 for VPA, 1 for CHD and 1 for Outsiders. Again out of the ratio 4 for the children of port employees, the sub-ratio of 2:1:1 will be followed to the children of deceased employees / medically invalidated & superannuated employees / serving employees respectively.
- Those who are short-listed basing on merit of marks secured in the qualifying exams will only be called for certificates verification.
- The trades will be allotted to the candidates at the discretion of the Head of the Department.

TRAVEL EXPENSES : TA & DA will not be paid by VPA for attending certificate verification.

BOARDING/LODGING : No boarding or No lodging expenses are admissible
