2.0 EDUCATIONAL QUALIFICATION

Note:-

- i. Candidates applying against the vacancies notified in a particular State, should have proficiency in the specified local / regional language i.e., Tamil (Neyveli, Tamilnadu). In support of local / regional language proficiency, candidates are required to produce SSLC / 10th Standard / Matriculation certificate as proof of having medium of study in local / regional language or having studied local / regional language as one of the subjects.
- ii. Minimum qualifying percentage of marks in the notified educational qualification (Diploma or Degree) in respect of Junior Overman (Trainee) is 60% (Aggregate) for UR/OBC-NCL/EWS candidates and 50% in case of SC/ST candidates against posts reserved.
- iii. Candidates who have passed the notified qualification only are eligible to apply.
- iv. Wherever percentage of marks is not awarded by the University / Institute and only Grades (GPA / CQPI) are awarded, the same should be converted to the exact equivalent percentage of marks for example "On a 10-point scale GPA / CQPI of 6.0 will be considered as 60 %."
- v. Wherever percentage of marks is not awarded by the University / Institute the candidate's final year / final semester mark sheet indicated as passed with I-Class, I-Division, I-class with distinction and II-Class, II-Division, etc., shall also be considered in addition to the Grand Total of marks in support of notified qualification.
- vi. For the purpose of calculating the aggregate final percentage of marks, the aggregate marks of all years / semesters / trimesters would be taken. Rounding of percentage (%) will not be acceptable under any circumstances, hence 60% of marks and above for UR/EWS /OBC (NCL) & 50 % of marks and above for SC/ST will only be considered for the post of Junior Overman (Trainee).
- vii. All qualifications should have been acquired from Indian Universities/Institutes, recognized by AICTE/DGMS (whichever is applicable) or any other appropriate statutory authority in India.
- viii. Qualifications which are regarded / classified as equivalent or having combination of branches other than the notified one will not be considered
- ix. Candidates who have acquired the Diploma in Engineering qualification privately through the State Board of Technical Education & Training / Department of Technical Education will be considered in case they got admitted to the course prior to AICTE becoming a statutory body in the year 1987.

3.0 CRUCIAL DATE:

- i. Age Relaxation for OBC (Non-Creamy layer)/SC/ST/Ex-Servicemen candidates will be as per Government of India guidelines and the same will be extended only if valid OBC (NCL) / SC / ST / Discharge Certificates are uploaded at the time of registration of application.
- ii. Candidates belonging to OBC (NCL)/SC/ST categories applying against unreserved vacancies shall be considered under general standard of merit and no relaxation in age will be extended.
- iii. Relaxation for Ex-Servicemen (ESM) category candidates is as per extant Govt. of India guidelines.
- iv. Upper age limit indicated above does not apply to employees currently on the rolls of NLCIL or its Subsidiary companies /Joint ventures. However, they should have minimum 02 years of remaining service as on crucial date.
- v. However, in all the cases of relaxation, maximum age limit is 58 years as on crucial date.

In Addition to the CTC mentioned above, Performance Related Pay / Unified Incentive Scheme (Annually), free Medical treatment for self & dependents and Group Insurance, as per rules will be provided. 6.0 PLACE OF POSTING

Selected candidates are liable to be initially posted at Neyveli Mines, Tamilnadu. However, they will be required to work in any Unit / Area / Place situated in India and abroad under the control of NLC India Limited or in any Joint Venture / Associate / Subsidiary company of NLC India Limited, to which they may be posted.

7.0 RESERVATION & RELAXATION:

- 7.1 Reservation and relaxations for SC/ST/OBC (Non-Creamy Layer)/ EWS / & Ex-servicemen candidates will be as per Government of India guidelines.
- 7.2 SC/ST/Ex-servicemen Candidates are exempted from payment of application fee. However, they have to pay a non- refundable amount towards processing fee.
- 7.3 The Upper age limit is relaxable by 5 years for SC/ST, 3 years for OBC (Non-Creamy Layer) as per Govt. of India guidelines. For Ex-Servicemen as per extant Govt. of India guidelines. However, in all the cases of relaxation, maximum age limit is 58 years as on crucial date.
- 7.4 Candidates claim to belong to EWS / OBC (NCL) / SC/ST / Ex-Servicemen category should necessarily upload valid EWS / OBC (NCL) / SC/ST / Discharge Certificate, as the case may be, issued by the Competent Authority. Certificate formats can be downloaded from "Forms" tab in Careers Page of NLCIL website www.nlcindia.in.
- 7.5 Candidates belonging to OBC (NCL)/ SC/ST/EWS categories should meet the eligibility norms notified for UR category for consideration against unreserved (UR) vacancies. In other words, OBC (NCL)/SC/ST/EWS candidates applying against unreserved posts shall be considered under general standard of merit and no relaxations (except payment of application fee) shall be available for the candidates.
- 7.6 Candidates belonging to OBC "Creamy Layer" are not entitled to avail any concession otherwise extended to OBC (NCL) category. Such candidates have to indicate their category as UR.
- 7.7 Candidates belonging to OBC (Non-Creamy Layer) category should upload valid OBC (NCL) certificate obtained on or after 01.04.2025 in the prescribed format (applicable for purpose of reservation in appointment to posts under Government of India as contained in DOPT Memo No.36036/2/2013- Estt. (Res.) dated 30-05-2014) obtained from competent authority.
- 7.8 Candidates belonging to Economically Weaker Sections (EWS) should upload valid Income & Asset certificate obtained on or after 01.04.2025 issued by the competent authority as per OM No.36039/1/2019-Estt (Res) dated 31.01.19 of DoPT, Ministry of PPG&P, Govt. of India.
- 7.9 Category (EWS/SC/ST/OBC (NCL)/Ex-servicemen) once filled in the online application form will not be changed and no benefit of other category will be admissible later on.
- 7.10 The Department of Empowerment of Persons with Disabilities, Ministry of Social Justice and Empowerment have identified the jobs/posts suitable to be held by persons with benchmark disabilities and the physical requirement for all such jobs/posts vide their Gazette Notification Dt.4th January 2021. 8.0 METHOD OF SELECTION:

- 8.1 Selection will be based on Written Test for 100 marks.
- 8.2 The Question Paper will consist of two parts; Part-I with 30 questions of General Aptitude comprising of Quantitative Aptitude, Reasoning and General Awareness (at Diploma level) and Part-II with 70 Questions on subject knowledge totally 100 objective type questions with multiple choice answers.
- 8.3 Question Paper for Written Test will have Multiple Choice Objective Type Questions carrying equal mark each, with no negative marks for wrong answer.
- 8.4 Duration of Written Test will be 120 minutes. The Question Paper will be in English Language only.
- 8.5 Minimum qualifying marks in Written Test will be 50% in respect of UR & EWS candidates and 40% in respect SC/ST/OBC-NCL candidates, against the reserved vacancies. For PAP candidates eligible for bonus 20 marks, minimum qualifying marks of 50% or 40% as the case may be, will be arrived after adding bonus marks.
- 8.6 Project Affected Persons (PAPs of NLCIL Neyveli Projects) will be allowed 20 bonus marks (limited to one beneficiary per award) in the overall marking system.
- 8.7 Final selection will be in the order of merit based on the overall total score of marks obtained in written test by the candidates (plus Bonus marks awarded in case of PAP candidates), ensuring due reservation for SC / ST / OBC-NCL / EWS categories.
- 8.8 In case of tie at cut-off level, (i.e.) more than one candidate scoring same marks (out of 100) at cut-off level, such cases will be resolved by applying the following criteria, one after another, till the tie is resolved:
 - 8.8.1 Date of Birth of the candidates, senior most candidate(s) by age will be placed higher;
 - 8.8.2 Alphabetical order of first name of the candidates.

9.0 PROJECT AFFECTED PERSONS (PAPs) of NLCIL:

9.1 PAPs falling under the following criteria will be considered as Project Affected Persons (PAPs) of NLCIL for availing the benefit of 20 Bonus Marks in this recruitment:

9.1.1 "Candidate

- (i) Should have handed over land/house with house site to NLCIL (or) should have 3(2) / 3(1) Notice to hand over land/house with house site to NLCIL (applicable for Neyveli Projects only).
- (ii) should not have availed Permanent job in NLCIL on PAP quota/One Time Rehabilitation Grant (OTRG) or Annuity in lieu of employment"
- 9.1.2 PAPs of Land Awards passed from the year 01/07/1989 of Neyveli Projects will only be considered.
- 9.2 The eligibility of the PAPs to avail the benefit of 20 Bonus Marks in this recruitment will be solely based on the recommendations of Land Acquisition Department / Neyveli.
- 9.3 The candidates must attach / produce the following documents / certificates to establish the status of PAP.
 - 9.3.1 "PAP Eligibility Certificate in the prescribed format (enclosed) issued by the Unit Head/Land Department in respect of Units in Neyveli"
 - 9.3.2 12 (2) Notice of the Award passed / Land Awardee Certificate (or) 3(2) / 3(1) Notice to hand over land/house with house site to NLCIL and duly certified by the Head of Land Department of NLCIL, Neyveli.
 - 9.3.3 If the awardee is not alive, the death certificate of awardee and legal heir certificate [Note: In case of Legal Heir, notarized consent of all other legal heirs in favour of the applicant for availing the benefit to be obtained (format enclosed)].
 - 9.3.4 If the awardee is alive, notarized consent of Awardee & family members in favour of the applicant for availing the benefit to be obtained (format enclosed).
- 9.4 In case of selection of candidates who have applied with 3(1) / 3 (2) notification, offer of appointment will be issued only after passing of Award and Physical possession of their land by NLCIL

10.0 MEDICAL FITNESS: -

Every provisionally selected candidate, prior to being appointed for the post, is required to undergo Pre-Employment Medical examination as per the prescribed health standards of NLCIL by the Company's Medical Officer and subject to being found Medically Fit, prescribed for the post. The candidature will be strictly rejected if the individual is found unfit to work in mines according to The Mines Rules, 1955

11.0 **GENERAL CONDITIONS**:

- 11.1 Only Indian Nationals are eligible to apply.
- 11.2 All qualifications should have been acquired from Indian Universities/Institutes recognized by AICTE or UGC or any other appropriate statutory authority in India.
- 11.3 Candidates from State PSEs / Central PSEs / Government / Quasi Government, should produce No Objection Certificate (NOC) at the time of document verification otherwise they will not be permitted to attend the written test.
- 11.4 Depending on the response and requirement, NLCIL reserves the right to raise / relax the eligibility conditions.
- 11.5 NLCIL reserves the right not to fill up any or all the posts notified at its discretion and vacancies may also be increased / decreased depending upon organizational requirements.
- 11.6 Candidates are informed that mere submission of applications shall not give them any right to be called for selection.
- 11.7 SC/ST candidates appearing for written test, to & fro travelling expenses to the extent of sleeper class rail fare by the shortest route (from their communication address to selection venue) shall be reimbursed, on production of proof of journey performed, along with reservation and the tatkal booking charges, if any. Reimbursement of travelling expenses shall be made only on production of ticket

- / proof for travel (Train ticket / Bus ticket) and NOC (in case of candidates from State PSEs / Central PSEs / Government / Quasi Government).
- 11.8 Candidates will be called for document verification based on Self certified information along with copies of testimonials uploaded by them. They should produce the original documents, in support of their meeting eligibility conditions, at the time of document verification failing which such candidates will not be permitted to appear for written test and Travelling Allowance will not be reimbursed to them.
- 11.9 Candidates already removed / terminated / deserted their employment from NLCIL will not be considered.
- 11.10 Persons already resigned from NLCIL may apply, subject to fulfilling the notified eligibility criteria.
- 11.11 A candidate who has availed Voluntary Retirement (VR) from CPSE/PSU/State PSU/Central Govt./State Govt. and having received ex-gratia payment as VR compensation can also apply provided that he/she is prepared to repay/return the VRS compensation to the PSU from where he/she has received such compensation to the extent required as laid down in the VR scheme/relieving letter and other Govt. rules as applicable at the time of VR. If such candidate who has got VR is selected by NLCIL the appointment order would be sent to such person only after getting clearance from the PSU concerned about the repayment of ex-gratia compensation.
